  - d. Colorado Department of Public Safety, Division of Fire Prevention and Control License.
  - e. Permission Agreement for the use of the property, if not owned by applicant.

## TEMPORARY FIREWORKS STAND INSPECTION REPORT (Delta Municipal Code Section 8.28.040)

- [ ] Plans reviewed and approved pursuant to City of Delta Municipal Code and current adopted building and fire codes.
- [ ] State permit posted on site.
- [] The stand shall maintain a minimum distance of twenty (20) feet from all structures and automobiles.
- [] The stands shall maintain a distance of fifty (50) feet from fueling stations.
- [ ] Provide and maintain safe entrance and exit areas around stand.
- [ ] The stand shall have a least one (1) exit door a minimum of twenty (20) inches in width and six (6) feet in height which swings out in the direction of egress. Stands over twenty-vide (25) feet in length shall have a least two (2) exit doors.
- [ ] All stands shall have at least one (1) fire extinguisher that is properly tagged. Stands over twenty-five (25) feet in length shall have a fire extinguisher at each exit.
- [] Vegetation around the stand shall be no more than two (2) inches above grade except for trees and shrubs.
- [] No smoking or burning shall be allowed within fifty (50) feet of the stand, and "No Smoking" signs shall be posted accordingly.
- [ ] No fireworks shall be discharged within fifty (50) feet
- [] Sales to persons under the age of eighteen (18) years are prohibited, and signs shall be posted accordingly.
- [ ] Provide list of all fireworks to be sold on site.
- [ ] Sales inventory must be available for inspection. Samples may be tested by inspectors for compliance with state and local codes. Sales area must be fully stocked prior to inspection.
