The issuance of a permit and specifications of terms and conditions therein shall not constitute assumption or create presumption that the local building department or its employees may be liable for the failure of any structure, nor act as certification that the materials used in the structure or any of its componenets thereof, or that the structure for which the permit was issued insures continuous compliance with the provisions of the Codes as adopted by the City of Delta. HOMEOWNER CLAUSE: Colorado Revised Statutes provide a homeowner the opportunity to perform the electrical installation provided the following are true: (1) you are the property owner and this property is not for sale, resale, or is not rental property; (2) you reside or intend to reside at this property as your sole place of residence; (3) you are doing the permitted work yourself and have reasonable enough knowledge of electrical codes for a property installation; and, (4) you understand that your homeowner's insurance may not cover damages to your home due to construction accidents. I hereby certify that I have read and examined this application and know the same to be true and correct. All provisions of laws, Codes, and ordinances governing this type of work will be complied with whether specified herein or not.
