Notice of Flood Risk Map Updates

December 2023 Update

The Federal Emergency Management Agency (FEMA) has provided the City of Delta with preliminary (draft) copies of new Flood Insurance Rate Maps (FIRM) and a Flood Insurance Study (FIS) report for review. These documents are preliminary, but if eventually adopted, the new FIRMs and FIS will be the primary documents used to identify flood risk, insurance requirements, and applicable development regulations for properties located within the regulatory floodplain in our community, as required to continue the City of Delta's participation in the National Flood Insurance Program (NFIP).

FEMA is presently giving our community an opportunity to identify and comment on changes or corrections to *non-technical information*, such as corporate limits, road names, and stream names on the FIRM panels or in the FIS report.

Your input is welcome on this non-technical review of the preliminary FIRMs and FIS. For your convenience, digital copies of materials received from FEMA and online interactive maps are linked below along with information on how to access the preliminary/draft documents via the Map Service Center. Hard copies of the materials can also be viewed at City Hall during business hours (8:00am to 4:30pm, Monday through Friday). Printed take-home copies can be provided upon request for a fee.

To submit comments directly to FEMA regarding needed changes to any non-technical information on the materials, contact Christine Gaynes with FEMA Region VIII. Comments for this stage of review are due by <u>December 21, 2023</u>. If you have any questions, please do not hesitate to contact City staff.

To access the preliminary/draft FIRM panels and FIS report released for review on November 21, 2023, go to the FEMA Map Service Center and search for your specific property address. Identify the specific FIRM panel number that includes your property (e.g., 08029C0602D). Then select the "Show ALL Products >>" button. Next, click the "Preliminary Products" dropdown menu.

From there, you can select the Preliminary FIS Report or the Preliminary FIRM Panels. Note that there are two volumes of the FIS, including Volume 1 which covers the Gunnison River and Volume 2 which covers the Uncompander River, and that there are 85 FIRM panels for all of Delta County, including those for the City of Delta. The preliminary FIRM panel numbers are the same as the effective, except that they end in "E" instead of "D" (e.g., 08029C0602E). A reference map showing the approximate areas covered by each preliminary FIRM panel is also provided (see Product ID# 08029CINDOB). In general, the City of Delta's FIRM panel numbers correspond to the following areas:

- Panel 0413E Northwest Delta
- Panel 0414E Northcentral Delta
- Panel 0418E Northeast & East Delta
- Panel 0602E Downtown & South Delta
- Panel 0606E East & Southeast Delta

To access the current/effective FIRM panels adopted August 19, 2010, go to the FEMA Map Service Center and search for your specific property address. Then view the interactive online map provided or download a snapshot of the interactive map by clicking "Dynamic Map." You can also download the entire FIRM panel by clicking "Map Image."

Following this non-technical review there will be a 90-day review period during which anyone in the community can submit comments, concerns, or suggested revisions directly to FEMA on the preliminary FIRMs or FIS. The City will send notice of the review period when it begins and will also host a community meeting during the 90 days to help answer questions.
